2. Providing funds or grants, scholarships and other forms of financial assistance to the needy and deserving students for pursuing education, vocational training, skill development etc.



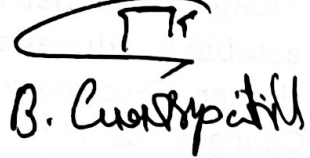

16. To organize various events and camps for searching, Encouraging, Nurturing and supporting sportsmen from weaker section of the society and provide them platform to showcase their talent.

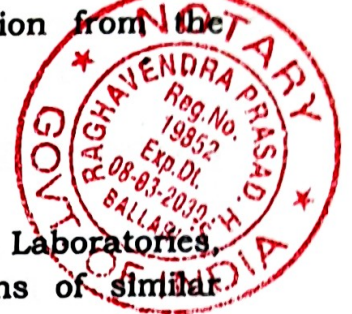

FUNDS AND ITS UTILISATIONS

27. To acquire and accept movable and immovable properties, funds, donations, gifts, sites, land etc., in the name of the trust from the Philanthropists, Parent's community, Govt., & Semi Govt., and other concerned authorities from within the country and abroad.

28. The trust shall receive Foreign contribution (FCR) as per specified statutory definition section (1) (e) of FRCA in form definition, Delivery or transfer made by any foreign source and other statutory Laws amended from time to time.

29. The foreign contribution and funds shall be utilized for the purpose of Education Cultural activities, Economic, and for Social work programmes as per Guidelines of Central Government and according to the FRCA 1976

30. To create a **CORPUS** fund exclusively by way of donations among resembling minded persons, if possible from public at large, within and outside India, by way of voluntary contributions, gifts, as such, any sort of donors has no right to interfere or involve in day today activities and affairs of the trust.

31. The trust will not carry out any activities with the intention of earning profit and will perform with service motive only.

MISCELLANEOUS

32. To carry on such other useful works which benefits humanity at large, for all **IRRESPECTIVE OF CASTE, CREED, SECT, COLOUR.**

RELIGION, COMMUNITY OR SOCIAL STATUS TO THE HUMAN RACE AT LARGE within the scope, limit and purview of the **LAW OF THE LAND.**

3. ROLE, RESPONSIBILITIES, POWERS, RIGHTS, AND DUTIES OF TRUSTEES:

1) The Roles, Responsibilities and powers of all these officers is defined below. In addition to these the managing Trustee may grant additional roles, responsibilities and powers to any of the Trustees

a) MANAGING TRUSTEE

In addition to discharging normal duties of a trustee, the Managing Trustee shall preside over meeting of the Board of Trustees. The managing Trustees authorized to sign all documents, including bank documents, acknowledgements for the contributions received, and agreements with individuals, Government institutions and other organizations, behalf of the Board of Trustees The Managing Trustees shall have all the residuary powers, not explicitly assigned to any of the other officers in these presents.

The Managing Trustee is authorized to sign along with the Treasurer bank cheques, deposit release vouchers etc. The Managing Trustee is empowered to remove any Trustee from the Trust and its officers, if

he/she finds that his/her activities are not ~~conformal~~ to the activities of the Trust.

The Managing Trustee is responsible for ensuring that the Trust pursues its Objects and for maintaining the dignity of the Trust organization and shall use his/her influence to promote the activities of the Trust.

b) VICE PRESIDENT

The Vice President shall discharge the duties of the Managing Trustee, in the absence of the Managing Trustee of the Trust and shall have the power and authority delegated and assigned to him/her by the managing Trustee.

c) SECRETARY

The secretary shall maintain the records of the organization prepare and circulate agenda and minutes of Board of Trustee meeting for the approval of the Managing Trustee.

The Secretary shall be also responsible for the day to, day administration activities of the Trust. The Secretary shall deal with correspondence received by the Trust, send replies in consultation with the Managing Trustee, Vice President and/ or the Treasure where necessary. He/she is responsible for the safe custody of all the properties and records of the Trust. The secretary shall represent the Trust in all legal matters, sign the papers related to legal cases, attend to courts or represent the Trust in Government offices.

d) TREASURER:

The Treasurer will prepare Annual Budget, monthly and yearly expenditure statements get the expenditure audited by the auditor duly appointed by the Board of trustees and place them before the Board of Trustees for approval The. Treasurer is responsible to maintain cash book and prepare vouchers for the payments made, receive contributions sign acknowledgements for the amounts or articles received by the trust and prepare monthly and yearly statements of revenue and expenditure, as well as, the register of assets of the Trust and place them before the Board of Trustees for their approval.

The Treasurer is authorized to sign bank cheques, application or drafts and payment instructions jointly with the Managing Trustee and draw money from the bank, up to the limits defined by the Board

of Trustees in their meetings The Treasurer is responsible for the custody of cash, bonds, securities etc. of the Trust.

2) The trustees in existence elect one managing trustee, secretary and treasurer, among themselves, for the purpose of functioning of day today affairs of the trust. In the event of any special programmed /project the trustees themselves, form a subcommittee to suit their project till the completion of the project to discharge their obligation and report to the trust.

3) The management of the trust shall be under the control and supervision of the trustees who shall have all powers, rights, liabilities and authorities expressed or implied, necessary or identical to or consistent with effective implementation of the objects of the trust.

4) Without prejudice to the above the trustees shall have the powers, rights and duties as follows:

A) To acquire, hold, invest all or part of the assets of the trust in movable or immovable properties and decide generally on all matters relating to arising there from.

B) To receive donations from the members, if required, from public at large for carrying out the activities of the trust.

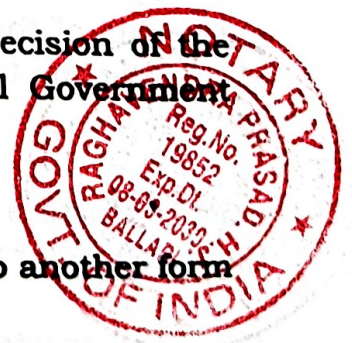
C) To determine, sanction, and /or allot the recurring or non-recurring capital and /or revenue expenditures of the trust or institutions created owned or managed under this trust.

D) To open and/or operate the accounts of the trust in any nationalized bank/s as the trustees may decide from time to time and decide the person/s to operate the accounts of the trust.

F) To change or alter the investments from one form into another form as may be decided by the trustees from time to time.

H) To borrow loans from Nationalized Banks, Private Banks, Corporate Sector Agencies and from Govt. Institution Like NABARD etc. towards development of Organization (Society)-and also repayment them in easiest installation

I) To improve, manage, develop, lease or otherwise deal with the trust properties, in such manner as may be decided by the trustees from time to time.

J) To institute, defend, prosecute, compromise any trust suit/s application/s dispute/s either any court of law or otherwise.

K) To appoint secretaries, managers, lawyers, solicitors, Auditors, Clerical staff, and or other employees for the purpose of the managements and supervision of the trust estate, collection of rents, effects and profits, etc. and for keeping accounts records, documents and for other purpose of the trust.

L) To take disciplinary action against the employees to maintain discipline, suspend or dismiss any employee as against them.

M) To frame rules, regulations, schemes to carry out the objects of the trust and for the management affairs of the trust and or for giving effect to the objects and purpose of the trust and vary it from time to time as the trustees may in their discretion, deem fit and proper.

N) To start, to discontinue, abolish, restart and etc., any charity or charitable institution to impose any condition / s to any subscriptions, any donation made by them, unto earmark any portion of the trust property and income for any particular objects.

O) To do all such deeds and acts necessary or incidental for the fulfillments of the objects of the trust. However they shall not apply, divert, or transfer the trust funds and assets of the trust for the benefits of author

trust or trustees or any relatives of either of them. It should be made use for the purpose, for which it was created to do so.

5) The trustees shall maintain proper books of accounts of the trust, trust activities and cause them to be audited every year in such manner as may be decided from time to time.

6) The ownership of the trust properties shall be vested jointly with the trustees.

7) The trustees shall exercise their powers at meetings called by the secretary and in such manner as may be decided from time to time.

8) The trustees may reimburse themselves and paid, discharge out of trust funds all expenses incurred by them in or about execution of the trust activities or any of their respective duties under these presents, including travelling expenses, but will not entitled to any separate remuneration.

9) The funds and income of the trust shall be solely utilized for the achievement of its Aims, objects and Memorandum and no portion of it shall be utilized for payment to the member by way of Profit, interest, salary and dividend etc.

4. OFFICE BEARERS OF THE TRUST:

The trust shall have the President (managing trustee), vice president, Secretary and Treasurer elected among themselves for the management of the trust and shall hold the office for a period of 5 (Five) years.

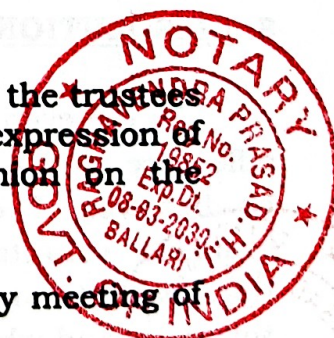
5. MEETINGS OF THE TRUSTEES:

6. BANK ACCOUNT:

The President, Secretary and the Treasurer any 2 of the mentioned persons shall jointly operate Bank Accounts on behalf of the Trust.

In the absence, any of the Trustees may be authorized by the Board of trustees, by a resolution, to operate the bank accounts one or more bank Accounts may be opened in any Bank and or Banks in the name of the Trust. Any of the founder trust can operate by the proper resolution passing in the meeting.

7. ACCOUNTS AND AUDIT:

- I. The financial year of the Trust shall be from 1st April to 31st March of the following year, unless otherwise decided by the Board of Trustees
- II. The Board of Trustees shall maintain true and correct accounts of the Trust.
- III. The accounts of the Trust shall be annually audited by a Chartered Accountant appointed by the Board of the Trustees and the audited statement of accountant shall be placed before the Board for its approval within three months of the close of the financial year

8. DISSOLUTION OR WINDINGUP THE TRUST:

In the event of death or retirement or even in the event of any dispute, difference, and / or dissolution under any circumstances the trust shall not be dissolved. The object of the trust shall be continued forever with the available voluntarily interested trustees/ and /or the same shall be transferred to another charitable trust whose object are similar to these of this trust and which enjoys recognition u/s 12A and u/s 80G of the Income Tax Act 1961 as amended from time to time.

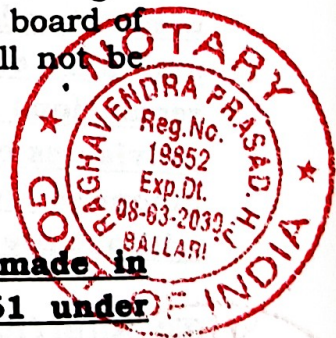

9. MISCELLANEOUS:

- A. The number of trustees shall be not less than **TWO** and ~~not more than~~ **TWENTY**
- B. Any Trustee may retire at any time, without assigning any reason and without being responsible for any acts occasioned by such retirements.
- C. No person being (1) VIOLENT persons (2) NON - FOLLOWER of the objects of the trust, (3) undercharged insolvent (4) convicted an offence involving moral turpitude (5) Unsound Mind (6) Disqualified as dishonest (7) Minor, shall be eligible to be a trustee.
- D. A person shall be ceases to be a Trustee, in any of the following events: -
If he dies, or he becomes bankrupt, or if he became insane or otherwise become incapable to act as trustee or if he resigns.
- E. On a new additional trustee being appointed and on his satisfying his acceptance in writing to the effect of his acceptance in writing to the effect of his accepting the appointment, the trust property shall automatically vest in him along with other trustees for the time being and he will be entitled to carry out all the duties and functions of a trustee without any other authorization / deed of document in writing, separately.
- F. The board of trustee may by a unanimous vote of all the trustees for the time being except the trustee proposed to be removed, remove any trustee permanent or otherwise from the office after finding the trustee proposed /acting found to be guilty of any sort of serious misconduct, acting against the aims and objects of this trust and in the interest of our trust activities, by recording concerned reasons in writing by giving fare opportunity to the concerned for the charges levelled against him for his removal. And the decision of the board of trustees in this behalf shall be final and binding and shall not be called in question anywhere

10. INVESTMENT CLAUSE:

The investment of the funds of the trust shall be made in accordance with the provisions if the Income Tax of 1961 under section 13 (1) (d), 13 (5) read with section 11(5) of the Act.



11. THE TRUST PROPERTY

Shall mean and include the following:

- a) The Corpus created by the author of the trust is the only property of the trust on the date of registration of this trust.
- b) Any contributions, grants, aids, donations, received collected in the form of cash or any kind either movable or immovable required from time to time or in any others name, which should fall on trust subsequently. It should be, if made, obtained in writing permission of the board of trustees.
- c) Any investments of the funds of the trust any other properties of the trust accredited there to.
- d) As on the date of registration of this trust deed there are no movable property and/or immovable properties in the name of trust.

12. The Trust shall be **irrevocable** one.

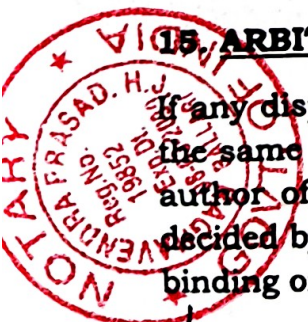
13. To take and amalgamate any trust which do have similar objects of this trust for management or to carry on the objects of the said trust.

Further, no amendment shall carry out without the prior approval of the commissioner of income tax.

15. ARBITRATION:

If any dispute arises between the trustee of any matter relating to the trust the same shall be referred to arbitration by sole arbitrator, who shall be the author of the trust or in case of his absence, by such person as may be decided by the trustees. The decision of the sole arbitrator shall be final and binding on parties to the dispute.
